Reporting an attorney for misconduct is a serious matter and should not be entered into lightly. Such claims should be investigated to ensure that it is more than a mistake or misunderstanding. I would follow the ethical rules about reporting misconduct or an infirmity.

9. How do you handle the drafting of orders?

It varies from case to case. I may request the prevailing party or both parties to send a proposed order either by email or through the electronic filing system. In some cases, a party will file a proposed order prior to the hearing though no request has been made. In other cases, I draft my own order without requesting or receiving a proposed order from any party. I review all proposed orders and amend as needed.

10. What methods do you use to ensure that you and your staff meet deadlines?

I or my staff run reports generated by court administration software that track all open cases, their age and status. Monthly reports are sent to court administration regarding the status of older cases.

11. What is your philosophy on "judicial activism," and what effect should judges have in setting or promoting public policy?

I base my rulings on the applicable rules and law regardless of my personal or political views.

12. Canon 4 allows a judge to engage in activities to improve the law, legal system, and administration of justice. What activities do you plan to undertake to further this improvement of the legal system?

Each year a Master in Equity organizes the Master in Equity Bench Bar CLE. If re-elected, I am to organize the 2020 conference. I have also

discussed presiding over the York County Drug Court Program and a Domestic Violence Diversion Program.
