In this position, I conduct jury trials, bench trials, and motion hearings for magistrate level civil and criminal cases. My duties include issuing arrest warrants and search warrants, when probable cause exists, for all levels of offenses and conducting preliminary hearings on charges ranging from shoplifting to murder. Additionally, I preside over General Sessions cases that are heard in Transfer Court.

In my current capacity as chief magistrate, I have significant involvement with the administrative and financial management of this entity. This includes managing and bearing sole responsibility for all the accounts associated with the Spartanburg Magistrate Court's central court and bond court. Additionally, I am responsible for reviewing the accounts and records of the district magistrate courts in Spartanburg County.

Judge, Seventh Judicial Circuit Adult Drug Court Program.

January 2010 – present.

In this position, I accept guilty pleas on charges ranging from shoplifting to burglary, encourage participants as they seek stable recovery, conduct hearings when there are alleged violations of the terms of drug court, and determine the appropriate sanction or sentence for violations of the terms of drug court.

There are several crimes with possible penalties that exceed 30 days or \$500 wherein the legislature confers jurisdiction upon magistrate court. Certain General Sessions cases may be transferred to Magistrate Court pursuant to 22-3-545. The civil jurisdiction for magistrates is set forth in Sections 22-3-10 and 22-3-20 of the South Carolina Code of Laws.

In my youth, I held several jobs that included driving a bus for Spartanburg County School District Two as a high school student, working at a Domino's in Spartanburg, working at a Pizza Inn in Spartanburg, and working at a Sears in Spartanburg for a few months between graduating from college in December 1989 and beginning law school the following fall. I do not recall the precise dates of my employment in these positions. I also worked as a page with the South Carolina House of Representatives during part of my time in college, but I do not recall the exact dates.

I currently serve as a member of the board of a nonprofit in Spartanburg, SC called Christmas in Action. My role is as a volunteer board member that is involved in monthly meetings and as a volunteer that works on sites each year after Christmas. My term began on July 1, 2019 and expires on June 30, 2022.

I do own a very small number of shares in two publicly traded banks. Since a master-in-equity presides over foreclosures and these banks could be involved in foreclosures, I would sell the stock before becoming a master-in-equity. While my interest in these banks is likely de minimis and would not require a disqualification, I would sell the stock just to remove the potential issue.

To do the job well, both must conduct themselves in a way that projects confidence and excellence, without arrogance, demonstrates neutrality regarding the outcome, and remains open to different interpretations of the rules or facts.

The most important influences in my life regarding work ethic were my mom and dad. I do not remember them talking a lot about work ethic as I was growing up, but I have vivid memories of them demonstrating a strong work ethic daily. They would have never considered showing up early and working hard until the job was done an attribute, because it would have never occurred to them to take another approach. In my professional life, many people have made positive comments about my work ethic, but I just think of it as fulfilling my responsibilities. While I appreciate the kind comments, I do not think that I deserve praise for doing my job and I cannot envision taking another approach.

As with work ethic, the most important influences in my life regarding honesty and integrity were my mom and dad. Again, they taught more by example than discussion. However, my dad did speak to me throughout my childhood about the value of a person's reputation for honesty and integrity. Because his usual approach was to lead by example, rather than words, these direct discussions had a profound and lasting impact on me. I place an emphasis on conducting myself in a way that demonstrates my integrity and honesty.

During my fifteen years of presiding over civil and criminal cases as a full-time magistrate I have presided over virtually every type of civil and criminal case that may be heard in magistrate court. Although I have conducted jury trials on a regular basis, my extensive experience conducting civil and criminal bench trials likely provides my best preparation for the nonjury responsibilities of a master-in-equity. As a judge, I have gained valuable insight and experience that I use to fairly apply the law to each litigant and conduct court in a way that respects all parties. To serve the public properly, judges must provide fair and efficient justice to each litigant while applying the controlling legal principles and law. While I realize parties are going to frequently be disappointed with the outcome of a case, I strive to conduct court in a way that instills confidence in the legal system and the specific process that led to the outcome. It is important, in my view, to explain the proceeding to litigants and to explain the basis for the ruling. If I am fortunate enough to be appointed as the master-in-equity, I will take this same philosophy and approach to that court.

My years of experience as associate chief magistrate and the chief magistrate for Spartanburg County has prepared me to fulfill the financial and administrative responsibilities of the master-in-equity. As the chief magistrate, I am directly responsible for all accounts and financial transactions involving the magistrate offices at the Spartanburg County Courthouse and the detention center. Additionally, I am responsible for reviewing the bank records and transactions of the seven district magistrate offices. Other duties include preparing budgets, approving office expenditures, and supervising all court staff. This experience operating a court system with six full-time judges and thirteen to fifteen part-time judges has prepared me for the administrative duties of the master-in-equity office.

Beyond my experience as a judge, my experience as a litigator has prepared me for this position. As a trial attorney for over ten years, I gained extensive experience litigating a wide variety of criminal cases in Circuit Court. These cases frequently involved complex motion hearings prior to trial and during trial. While arguing these cases, I was able to observe and learn from some of South Carolina's finest Circuit Court judges. My observations of how these judges

conducted court and conducted themselves served as a model for me when I became a magistrate judge.

Before I ever thought about becoming an attorney or a judge, I learned the importance of examining all of the evidence and weighing it fairly from a childhood event. When I was a young boy, my dad looked out our kitchen window and saw a young man from the neighborhood placing a nail under one his tires. My dad yelled to get the young man's attention. The young man ran toward his house, leaving a nail under my dad's tire as evidence of the act. My dad called the young man's dad to tell him what happened. My dad's honesty has never been questioned and he would have sworn under oath that he saw the young man place a nail under his tire. He saw the young man under his truck, with his hand on a nail, and the nail was placed to go into my dad's tire the next time he backed out of the driveway. Open and shut case, right?

Now, the rest of the story. Just as the young man's dad is about to discipline him, the truth is revealed. The dad did need to discipline someone, but it was his other son. As the other son confessed, he had placed a nail under each of my dad's tires without detection. When he returned home and bragged to his brother about his exploits, his brother raced to my dad's truck to remove the nails before the tires were damaged. The young man had already removed nails that were under three of the tires and had his hand on a fourth nail to remove it when my dad saw him through the window. This early lesson about not jumping to conclusions, examining all of the available evidence, and weighing it fairly has remained with me during my career as a judge and lawyer. As the master-in-equity, I would continue to carefully examine any evidence presented, weigh it fairly, and apply the applicable law.
