Over the past five years, I have handled ordinary commercial foreclosure matters and a contested foreclosure matter that included the appointment of and working with a receiver, the interpretation and application of loan documents, and obtaining a writ of assistance. I have also handled homeowner's association foreclosures and contested issues related to the application and interpretation of condominium master deeds. Within the past five years (excluding those times when the courts were closed due to COVID), I have regularly appeared before a Master-in-Equity or a Circuit Court judge approximately once a month for motions, trials, or other hearings.

Prior to joining my current firm (April 2017), I served as sole counsel in most matters (85%), and co-counsel in complex litigation (15%). In my current firm, I have purposefully sought to be lead counsel with an associate on most (60%) matters with the remaining cases as either sole counsel or as co-counsel in complex matters.

 - (a) Asset-Backed Lending Partners, L.P. v. Blackbook Holdings, Inc. (2016-CP-26-1523). The case is significant because of its complexity and the factual and legal issues involved. I represented the Lender in this contested commercial foreclosure matter encompassing 33 rental condominium units at a 60 unit development, an additional condominium at a high-end resort, and an amenities center at an unrelated development. In this matter, I had a receiver appointed to take over the rental units and amenities center and worked with the receiver to take control of the units. I also worked with the receiver to take over the management of the condominium regime (the debtor owned a majority of the units) and to bring the regime into compliance with its fiduciary duties. I successfully defended motions concerning discovery issues and had the Borrower's counterclaims and jury trial requests dismissed. At the conclusion of the foreclosure process, I also worked with the sheriff's office through a Writ of Assistance regarding holdover occupants.

- Condo-World Development, LLC et.al. v. Myrtle Beach Golf & Yacht Club (b) Association, Inc. (2015-CP-26-3173). This case is significant because the lawyers and the parties worked for years to obtain a successful resolution between a golf course developer and the surrounding homeowner's association. In this matter, the owner of the former Heron Point Golf Course sued our firm's client, Myrtle Beach Golf & Yacht Club Association, Inc. The case concerned complex issues of property law such as ambiguous deed restrictions and deed descriptions, indenture deeds, negative reciprocal easements, unfiled property agreements, and a prior bankruptcy of the developer. Due to the complexity of the legal and factual issues, I worked with co-counsel on the legal and discovery issues raised in the litigation. Ultimately, we were able to resolve the case on terms that would protect the homeowners' property values but also allow the golf course owner to develop its property. We worked closely with civil engineers to craft a settlement whereby the homeowners purchased those parts of the golf course behind their homes while allowing the development of the clubhouse area. This required the careful and detailed drafting of agreements concerning the use and upkeep of certain roads and drainage facilities, and the granting and cancellation of certain easements. We also worked to have both Horry County Planning Department and the Circuit Court to approve our proposed agreement. With golf courses throughout Horry County being closed and redeveloped our settlement is a model for how two opposing sides can reach a resolution that protects everyone's property interests.
- (c) Cole, et.uno. v. Town of Atlantic Beach Election Com'n, 393 S.C. 264, 712 S.E.2d 440 (2011). In light of the events surrounding the Presidential election of 2020, this case is significant because it firmly established that Election Commissions must carry out their duties properly and in a timely manner. In this case, I insured that the will of the voters was carried out despite Election Commission interference. This matter arose from the decision of the Atlantic Beach Municipal Election Commission to de-certify the election of the plaintiffs to the Town Council and to order a new election. The underlying issues involved the plaintiffs' residency and certain challenged ballots, primarily absentee ballots. My representation of the plaintiffs began with their appeal from the Municipal Election Commission to the Circuit Court, which affirmed the Commission. I directly appealed this decision to the Supreme Court. The Supreme Court unanimously reversed the decision of the Municipal Election Commission and immediately ordered the seating of the Plaintiffs.
- (d) NAACP v. City of Myrtle Beach, (U.S.D.C. D.S.C. No. 4:03–1732). Our firm represented the City of Myrtle Beach in a suit brought by the NAACP challenging certain policies of the City during the Memorial Day Bikefest, and particularly the traffic pattern on Ocean Blvd. I managed most of the discovery in this matter and worked closely with City officials during the litigation. Legally, the significance of the suit lay in the political and constitutional issues presented and the substantial amount of discovery conducted. On the eve of the May Bike Weeks, the District Court issued a preliminary injunction against the City. Cynthia Howe and I obtained an emergency stay of that order from the Fourth Circuit Court of Appeals.

Professionally, this case taught me how to manage complex litigation and how to manage a very public case. This case also taught me the importance of seeing a matter from the perspective of the other litigants, and thereby better understanding their arguments and positions.

(e) AVX Corporation v. Horry Land Company Inc., (U.S.D.C. D.S.C. 4:07-cv-03299)

John Henry Nance v. AVX Corporation, (2008-CP-26-0436)

In these two cases, our firm and an associated firm represented two neighboring landowners whose property allegedly suffered environmental pollution from a neighboring industrial facility. Both matters were tried before a jury. Horry Land was confidentially settled at the close of the plaintiff's case and Nance was confidentially settled after verdict. Professionally, the significance of these cases lays in being part of a legal team to bring these document and witness intensive cases to trial. It also lay in fighting through numerous evidentiary issues at the trial of the cases.



I was taught that every human being has inherent dignity and worth regardless of their station in life, their opinions, or their actions. All people, even those with whom I disagree or to whom I have been adverse, require my respect as being created in the image of God. To truly love your neighbor as yourself means to find the person before you loveable, and not in spite of, but in a full understanding of their imperfections and failings. It means to approach others with a deep humility and to ultimately value them above myself.

Jim taught me to always put the client first and taught me to keep my legal arguments clear and cogent. If a thought could not be explained in short words and short sentences, then I did not clearly understand what I was saying. Cindy taught me that the law is an exercise in the written word and that my writings should be perfect when they left the office. My time practicing law with Jack Thomas and Clay and Emma Ruth Brittain reinforced these values of a client-focused legal practice that demands excellence in my work product.

As a Master-in-Equity, these values of humility, hard work, and excellence would be those values to guide both myself and my staff. Everyone that comes into my courtroom or interacts with my office would be treated in accordance with their God-given dignity. I and my staff will work hard to fulfill our duties to the litigants and to the judicial system in general. Although, if elected, I intend to end my legal career as the Master, I see this position not as a reward, but as a new opportunity to work hard and serve my community in a new way. And in all matters, I will expect excellence from myself and my office in carrying out our duties.
