These fees were paid prior to the foreclosure action and a Stipulation of Dismissal as to me was entered on June 3, 2014.

In Bank of America vs. Jason Ashton Dawson, et. al, 2014-CP-26-3246. A Stipulation of Dismissal as to me was entered April 17, 2014.


My firm has recently been named as a Defendant in the following action:
