 - (a) Immediately following law school, and prior to the bar exam results, I became the judicial law clerk to the Hon. John L. Breeden, Jr. (2002-2003) Circuit Court, At-Large, Seat 13. In this position, I experienced and assisted in the exercise of judicial responsibilities, and the procedural and mechanical operations of the judge within the Court system. in this capacity, I served the Court during two death-penalty matters, one of which went to a full trial and sentencing.
 - (b) In 2003, I joined the Fifteenth Judicial Circuit Solicitor's Office as an Assistant Solicitor (General Sessions). I managed a caseload of between 300-550 warrants from filing to final disposition in Circuit Court. The allegations within the warrants ranged from misdemeanor citations to all degrees of homicides, including homicide by child abuse, criminal sexual conduct, drug offenses, and other serious violent crimes against persons and property. in each instance, I sought justice for every defendant and victim, and the public, as appropriate.

- I attended several training courses at the US DOJ's National Advocacy Center. I was approved by the SC Criminal Justice Academy to teach the Legal portions of the SC Constables Training Courses at the Horry-Georgetown Technical College.
- (c) Between 2008-2009, I served as a college-level Adjunct Professor of Business Law teaching night classes at The Golf Academy of America's Myrtle Beach Campus.
- (d) In 2010, I joined the Office of The Horry County Attorney as the Assistant County Attorney. During the course of my tenure, and with growth in the office, I was promoted to Chief Deputy County Attorney. In these capacities, I acted as a counselor-at-law to assist the Council, department heads, and all County Boards and Commissions in the legal and functional aspects of government within their scopes of operations. I served as an attorney/advocate and represented governmental entities as needed in the Courts of the state, to include the Circuit, Magistrates, and Administrative Law Courts. I served in the role of a mediator to assist in reducing and/or resolving intra-county conflicts of opinion or procedure. I acted as lead counsel for the decennial redrawing of County Council (and Horry School Board) Districts following the release of relevant US Census Data. I acted as the advisor to the County Elections Commission and represented the County in Circuit Court elections disputes.
- (e) In 2014, I opened The Office of Sanford Cox Graves, P.A. in Conway as a sole practitioner. I serve as the administrator and financial manager, including oversight of the firm's trust accounts. The office handles general legal matters as they present themselves to include defense of criminal and traffic matters, business entities, and some governmental consultation.
- (f) Also in 2014, I was appointed by the SC Chief Justice to serve as the Interim Presiding Judge over the Horry County Drug Court: the incumbent Probate Court Judge who had presided lost her primary election for the office. I continued in this capacity until April 2015.
- In 2015, I became an Associate at the Floyd Law Firm in Surfside Beach, SC where I practiced general business law. While I was included in general discussions regarding firm finances, beyond my own client billing and expenses, I exercised no power over any accounts, trusts, balances, or dispositions. I resigned from this position in 2017 to become the contract City Attorney for the City of Conway.
- (h) In 2015, I was appointed to the Board of Directors of The Horry County Solid Waste Authority by the Horry County Council. While the Board secured its own official legal counsel, I used my legal training and experience to guide and influence my positions and votes to benefit the Authority. I resigned from this position in 2017 to become the Contract City Attorney for the City of Conway.
- (i) In 2016, I was nominated and elected State Chancellor (Attorney) of the South Carolina Society of the Sons of The American Revolution where I served for one year.
- (j) In 2016, I joined the South Carolina State Guard (SCSG) at the rank of Captain in the Professional Services Division serving as a Judge Advocate. In 2020, I was promoted to the rank of Major. In this capacity I have been a legal advisor to the SCSG Brigade III in the coastal counties of SC, provided legal analysis to my superiors within command authority, been the legal advisor attached to the South Carolina Military Academy overseeing the training of SCSG Officers and Enlisted

Troops, earned numerous commendations and citations, attended military training and disaster relief exercises, and was deployed for disaster relief efforts following major storms in South Carolina. I have presented content at the annual SC Bar Military Training CLE program. I have participated in several free wills clinics and provided free legal services to veterans and law enforcement officers throughout the state. I have participated in Soldier Readiness Processing (SRP) activities for the South Carolina Army National Guard (SCANG) at Mc Entire Joint National Guard Base. I have contributed over 1,000 volunteer hours to this organization.

- (k) In 2017, I reopened Sanford Cox Graves, P.A. and physically located at 913 Third Avenue, Conway SC. As the sole practitioner and operator of the firm, I am in control of the general and specific finances of the firm, as well as the safekeeping of assets and accounts held in trust. While my primary client was the City of Conway, I assisted other clients with wills and trusts, business entities, defense against criminal charges in Municipal, Magistrate, and General Sessions Courts typically within the Fifteenth Judicial Circuit. In 2021, I became a Certified Circuit Court Mediator.
- (l) In 2017, I secured the contract to serve the City of Conway as the City Attorney and Municipal Prosecutor. In this role, I prosecuted municipal level criminal offenses in the City Court, gave legal support and advice to the municipal police department to include operations, certifications, and cases, and representation at SLED/Criminal Justice Academy appeals. I supported the operations of the City Council and departments to include general counseling in business and contracts, real estate transactions, administrative hearings, FOIA, governmental regulations and compliance, public relations and actions, ADA disputes, and mediation functions.
- (m) In 2020, I was appointed to the position of Associate City Judge in Conway. In this capacity, I was the City's Department Head for the Municipal Court. I managed staff, including the Clerk of Court, and held ultimate responsibility for the Court's cash transactions. on a daily basis, including weekends and holidays, I attended to the business of the Court including: presiding over Court sessions in the absence of the City Judge, daily bond hearings and associated documentation, warrant requests from law enforcement and the public, record-keeping, legal education and certification, and Court correspondence with Court Administration, City Council, and other authority.
- (n) From 2023 to present, I am an Adjunct Professor of Business Law at Coastal Carolina University. I teach an upper-level (300) general business course to business major students seeking non-legal business degrees within the E. Craig Wall College of Business. Successful completion of the course is a specific graduation requirement. the covers foundations of legal principles and law, jurisdiction and operation of the Courts, agency and employment, and business forms and entities.

I have extensive experience in criminal matters before the Circuit Courts in South Carolina. I have experience gained as a Judicial Law Clerk for one year in the Circuit Court, followed by almost 7 years as an Assistant Solicitor assigned to General Sessions. In both roles, I was in the Courts on a daily, or at least, weekly basis. I have tried or co-tried several cases in the Circuit Courts, including murder, homicide by child abuse, assault & battery with intent to kill, trafficking in drugs, burglary, and other lesser crimes. I have assisted in the judicial process on death penalty trials as a Judicial Clerk, and I have supported the prosecution in other death penalty cases within the office. I have processed several hundreds of warrants through the Circuit Courts by way of guilty plea: several of these cases were extremely technical including Felony DUI resulting in deaths which involve the SCHP MAIT Team. I have prosecuted evidentiary (i.e. Schmerber) motions, preliminary trial motions, and other scheduling motions in the Court. My successful prosecution rate was over 90%.

In General Sessions, within the past five-years, I have represented several defendants accused of criminal charges to include: Armed Robbery (bank), Armed Robbery (persons), Kidnapping, Criminal Sexual Conduct with a Minor, Distribution of Drugs, gun violations, etc. these matters did not go to a full trial because of the relevant and available facts in each case, as well as the consideration of the

individual solicitors involved to reach the ends of justice. As such, I have appeared in General Sessions Court approximately 10 times within the past 5 years.

Again, I have significant experience in the Court of Common Pleas relating to my work as a Judicial Law Clerk. I have additional experience representing the governmental bodies for whom I was employed. Most of this work involved right-of-way condemnations, civil disputes where my government was a named defendant, cases brought on behalf of governmental entities motions practice and injunctions hearings, as well as representing a police agency to have superfluous and extraneous materials excluded from a criminal case. I have represented civil defendants in Common Pleas where no insurance defense was available to them.

While my most significant experiences in Circuit Court are beyond the time frame requested by the Commission, it is primarily driven by the nature of the business and legal exposure of clients I recently served. as well as the fact that during part of the time I served in a judicial capacity. I do not believe that I lack experience in this area. however, to compensate for any suspected gaps, I read and study the Rules of Civil and Criminal Procedure, the Appellate Court Rules, the Rules of Evidence, the Advance Sheets, and Black's Law Dictionary, and I will attend Court in-session as a nonparticipant.

Please also note that the published starting date for the individual selected this judgeship is January 1, 2025. that date is 17-months from this application, screening, and campaigning, and about 11-months from the General Assembly vote. As an outcome of this 2023 judicial selection process, and pursuant to South Carolina Constitution Article V, §18, the newly elected judge will serve the unexpired term of 6-months from the incumbent judge's published retirement on December 31, 2024, until the expiration of his remaining 6-year term on June 30, 2025. The individual elected in this current process will need to re-apply and run again next year in the 2024 judicial election process to secure their own first 6-year term beyond June 2025. Factually, they will effectively face a second election before they ever meaningfully take the bench to preside.

I assure this Commission, the General Assembly, and the public that within the denoted times frame given, I will continue to be an active practitioner in the field of law, and a diligent student of the law and procedure, and I will be preeminently prepared to assume the role and to be a successful representative of your trust.

15. List five of the most significant litigated matters you have personally handled in either trial or appellate court, or before a state or federal agency. Give citations if the cases were reported and describe why these matters were significant.

- (a) State of South Carolina v. J. Bardelli: I appeared as defense counsel, guilty plea not Appealed or reported. the defendant in this case was one of several people charged in an armed robbery and drive-by shooting, followed by another armed robbery/kidnapping. What made this case significant was that my client was not a primary actor to any of the crimes, and that a factual showing of 'mere presence' was required. once the fact was established to a degree agreeable to the prosecution, a resolution in the interests of justice was crafted. The defendant now owns his own business and makes a significant and positive contribution to society.
- (b) State of South Carolina v. R.A. Eargle: I appeared as defense counsel, guilty plea not appealed or reported. Defendant accused of sexual relations with a minor. Discovery disclosure from an unrelated case showed the victim was involved with gang-related individuals and was arguably depicted in photographs performing a sex act with a different gang-involved male. The prosecution was unwilling to consider the mitigating evidence, however, as the Rules of Evidence would bar its admission in a trial. The case was resolved by a guilty plea, wherein the judge sentenced the defendant in a manner that was calculated to meet the ends of justice.
- (c) State of South Carolina v. Wesley Smith: 705 S.E.2d 491, 391 S.C. 353 (S.C. Ct App. 2011), 406 S.C. 215 (S.C. 2013) Co-Counsel in the prosecution at trial of Homicide by Child Abuse (HBCA)/Aiding Abetting HBCA. Victim: Ebony (4 months old) cause of death: pseudoephedrine poisoning and numerous fractures to the infant's ribs. This case and week-long trial necessitated evidence and expert opinions from numerous medical professionals as to the nature, extent, and timing of the victim's injuries, and her eventual cause of death.

The prosecution used <u>State of South Carolina v. Fletcher</u>, 664 S.E.2d 480 (S.C. 2008) (reversed on other grounds) to bring in evidence of infant's prior radial fracture of the femur as absence of mistake. The case resulted in a conviction for Aiding and Abetting Homicide by Child Abuse and the defendant was sentenced to 20 years in SCDC. While the SC Court Of Appeals upheld the conviction, the Supreme Court reversed and remanded on the grounds that the Aiding and Abetting HBCA was not a lesser-included offense to HBCA, and as the particular charge was not the subject of its own indictment, the conviction could not stand.

- (d) <u>State of South Carolina v. Steven Edward Latham</u>: appeared as prosecutor, guilty plea Felony DUI with Death (x2). Prosecution involved detailed technical presentation of expert testimony from SCHP MAIT Team including computer reenactments of the collision.
- (e) <u>State of South Carolina v. D.A. Brown</u>: Appeared as defense counsel, guilty plea not appealed or reported. Case involved a charge of Armed Robbery of a bank (the presence of a weapon was represented in a note, but not actually presented into view). The defendant was quickly arrested in his nearby home with the stolen cash. This case involved the mitigating factor of capacity based on severe drug addiction and accompanying acute mental health issues. The defense made sufficient

showings to support the Court's referral to SC DMH and SC DDSN for official medical/mental evaluation reports. During the pendency of the evaluations, the defendant remained incarcerated. The judge considered all the factors and sentenced the defendant in a manner to meet the ends of justice.

18. Have you ever held judicial office? If so, list the periods of your service, the courts involved, and whether you were elected or appointed. Describe the jurisdiction of each of the courts and note any limitations on the jurisdiction of each court.

Yes. Twice.

First, I served as the Presiding Judge of the Horry County Drug Court (2014-2015) after being appointed by the South Carolina Chief Justice. The incumbent Probate Court Judge, who normally presided, lost her primary election. No candidate had won the general election or taken the oath. I was appointed to preside until such time as a newly elected judge chose to exercise the authority of their office.

The outermost authority of this Court is limited to the sentence imposed by the Circuit Courts as exercised in Horry County criminal cases, and as additionally based on elements of contract. the participants of the Drug Court are sentenced by the General Sessions Court to an active-time sentence in the state prisons, however such sentence is "suspended pending the successful completion of the Drug Court." The Drug Court Judge's role is to supervise the weekly progress of every participant as to their health, wellness, addiction recovery, positive social interactions, curfews, monetary obligations, employment, and absence of police interactions. compliant participants receive public praise, relaxed obligations, and promotions from the judge. Non-compliant participants receive public constructive criticism, sanctions, increased obligations, demotions, and, in the most extreme cases, a revocation the result of a Drug Court Judge's finding for revocation is that the participant is removed from the program and the Circuit Court Judge's sentence, suspended pending "successful completion" of the program, becomes an active sentence, and the participant goes from the Drug Court directly to prison.

I also served as the full-time Associate Municipal Court Judge for the City of Conway (2020-2021) as appointed by the Conway City Council. The jurisdiction of the Court is limited to criminal matters and ordinance violations which have factually occurred within the city limits, and within the 30-days/\$500.00 jurisdictional amounts. In this role, and after

the completion of Court Administration's mandatory training, I worked daily, including weekends and holidays, to set criminal bonds, judge factual presentations for warrant requests, preside over Court sessions, prepare and file legal documentation and Court records, supervise staff, and bear responsibility for the financial activity within the Court.

I answer this question from the perspective that the orders and opinions listed are the most significant to me. While much of the judicial work in which I have participated would not be significant in the greater scope and scale of statewide justice, and far short of appearing in a report or worthy of critical review or appellate adjustments, I believe these examples can illustrate to you the mechanisms of South Carolina justice at the lowest personal and functional level, as well as to show how I approach my work therein.

- (a) Drug Court Management: I am very pleased to have been chosen for the role as Presiding Judge over the Horry County Adult Drug Court, and to be a member of the team of professionals and staff who are the real operators of the program. I believe that the goal of the Drug Court is consistent with uplifting the dignity of mankind, and is a difficult and firm, but compassionate, method to help change the destructive behavior of people who may no longer be capable of manifesting their own positive choices. while there is no one person or participant I would name to address this question 19, please know that on numerous occasions, I have encountered participants and graduates in public: these people offer me their appreciation and are unhesitatingly proud to tell me about their new lives, accomplishments, professions, successes, and family reunifications. I remind them that while I may have been a visible agent, they were the authors of their own change.
- (b) Drug Court Revocation: Not everyone has the heart, stamina, and concentration to complete this transformational program. Some participants could have possibly made better time by not entering the program at all. As unforgiving as the program can be, there are mechanisms included which are designed to retain participants who are truly struggling, but also to highlight and add additional pressure to those who are attempting to manipulate the process. As to the latter, one such individual stands out to me as an example. During his time within the Drug Court, he made misleading statements relating to the way he spent his time and efforts towards his mandatory employment requirements. For these mid-level transgressions, he was sanctioned to additional community service hours. In reporting at the next Court session, it became evident within the documentation provided to the Court that he was claiming the same clock-based hours for both work and community service. When confronted with the deception he initially denied the facts, at a hearing set for the following week, and in session with all the other Drug Court participants, the individual was removed from the program, and his previously suspended sentence was activated. There is a community within the Drug Court participants, and it is a

moving moment to see one of their own that was not focused on recovery to be sent to prison.

(c) Drug Court Graduation: The pinnacle of success for struggling former drug addicts is graduation. As the Presiding Judge, I have witnessed the gradual and foundational changes the participants undergo within the program. It is a blessing to see and recognize the new lives the Drug Court graduates have, and it is a heartfelt joy to release the graduates from their suspended sentences and move them out of the criminal justice system by virtue of officially processing their successful completion of the program.

After my term, I have returned to the Drug Court for graduation ceremonies.

- (d) As the Associate Municipal Court Judge for the City of Conway, one of my main daily duties was the processing of bond documents and the holding of bond hearing for individuals charged with crimes committed within the city limits. Within this special role, and following the training promulgated by Court Administration, it is important to recognize that the mere charging of an individual does not equate to guilt, and following the presumption of innocence before a neutral and detached authority the purpose is to set a bond sufficient to protect the community and to ensure that the individual will return for subsequent Court proceedings. I developed several scripts to use as guidelines and rewrote them after completing judicial training through Court Administration. I efficiently and fairly completed these tasks on an almost daily basis and included weekends and holidays as required for the position.
