 - (a) Coleman v Mariner Health Care, Inc., 407 S.C. 346, 755 S.E.2d 450 (S.C. 2013)

 There is a movement in favor of arbitration in American Jurisprudence. This case sets forth that although arbitration is preferred, the South Carolina statutory and common law does not authorize a sister to execute a separate voluntary arbitration agreement presented to her by the nursing facility. This was a complex question where reasonable minds could differ. The Supreme Court affirmed my decision.
 - (b) Miranda C. v. Nissan Motor Co., 402 S.C. 577, 741 S.E. 2d 34 (Ct. App 2013)

 The law of product liability is constantly evolving and this case provides clarity as to the proper charge in a defective design products liability case. The jury in this case rendered a verdict against Nissan for \$2,375,000.00, which was subsequently set aside by my order in the wake of the Supreme Court's ruling in Branham vs. Ford Motor Company, 390 S.C. 203, 701 S.E.2d 5 (2010). The Branham case was decided after the verdict and before my ruling on post-trial motions. Branham establishes that "the risks utility test" is the proper charge in a design defect case which requires the Plaintiff prove a "reasonable alternative design". Because Branham changed and/or clarified the proper test in a design defect case, I granted a new trial. My decision to grant a new trial was affirmed.
 - (c) State v. Senter, 396 S.C. 547, 722 S.E.2d 233 (Ct. App 2011)

 Defendant was convicted of assault and battery with intent to kill and criminal domestic violence of a high and aggravated nature. His conviction was affirmed and The Court of Appeals opined that my denial of the Motion for Directed Verdict was proper, reaffirming the law and my ruling that Defendant cannot waive a trial by jury unless the State consents to do so.
 - (d) Mitchell v. Fortis Insurance, 385 S.C. 570, 686 S.E.2d 176 (2010)
 In this case, a policyholder brought causes of action for Breach of Contract and bad faith rescission against insurance company. The jury awarded \$15,150,000.00. Numerous orders were issued and many evidentiary rulings were affirmed, however, the Supreme Court reduced the verdict to \$10,150,000.00.
 - (e) Willis v. Wukela, 379 S.C. 126, 665 S.E.2d 171 (2008)
 South Carolina Supreme Court affirmed my ruling, clarifying S.C. Code Section 7-13-350 and its application.

Jerva Edwards is a pro se Plaintiff who filed this lawsuit alleging he served time in excess of his sentence. Although the lawsuit is filed in Federal Court, I have never been served with the pleadings.

(c) T. Terrell Bryant v. Michael Nettles, et al January 7, 2010. 4:10 CV 0027-TLW

This is a pro se civil action filed alleging irregularities in Plaintiff's indictment. Although this lawsuit was filed, I have never been served with the pleadings.

(d) David Washington v. Michael Nettles, et al

March 2, 2007. 4:07 CV 00619-RBH

This is a pro se Plaintiff who brought a lawsuit concerning an automobile accident. He named me, Judge Thomas A. Russo, Magistrate Cox, the Clerk of Court and others. I have never been served with this lawsuit and cannot glean from the pleadings what his cause of action is or how I am involved in this controversy.

(e) <u>United States of America v Kenneth Wade Stone, Michael Nettles, et al</u> August 1992. 92-CP-21-1199

This was a foreclosure action against Kenneth Wade Stone. By virtue of attorney's fees awarded to me in a domestic action, I was named as a creditor.

(d) Ora Galbreath v Michael Nettles

May 2, 2003. 03-CP-21-00844

The Defendant is not me. There are three people named Michael Nettles in Lake City alone. It must be one of them.

(e) Eric Sebnick v. Michael G. Nettles

September 9, 2004. 04-CP-21-01647

This is a personal injury lawsuit that was filed out of a minor automobile collision that took place in a parking lot. I was at fault. The case was settled for a portion of the chiropractor's bills incurred by the Plaintiff.

- (f) T. Terell Bryan, #254638, a/k/a Terence Bryan, a/k/a Terence Terell Bryan v. Hampton County Clerk of Court, Michael Nettles, et al July 7, 2010. 40:10-27-TLW
 - This is a pro se civil action. Although the action was filed, I have never been served With such pleadings. Judge Terry Wooten dismissed this action on July 21, 2010.
- (g) M. Gibbs, Esq., et al v James E. Lockemy, in their official capacity as Chief Judge Court of Appeals et al. (Appellate Case No. 2021-001282)

 Eugene Gibbs is a disbarred attorney who was defending a foreclosure action for non-payment of a mortgage. I presided over the foreclosure hearing. His presentation was non-sensical with no basis in reality. He maintained that the T.V. star, Bill Cosby, The Nations Bank, myself along with other named defendants entered into a conspiracy related to the theft of fine art. The case was dismissed in 2021.
- (h) M. Gibbs v Bank of America, N.A.; Nationstar D/B/A Mr. Cooper, B. Gibbs; United States; Freddie MAC; Federal Housing Finance Agency; Judge Michael G. Nettles; Alan M. Wilson, SC AG; Chief Judge Wendy L. Hagenau; McGuire Woods, LLP; William "Toll" Cosby; Peter Stern, ESQ.; Michael Rosenfeld Art Gallery; Smithsonian Institution; NAACP; Al Sharpton; Black Caucus, U.S. House of Representatives; Rod Rosenstein [USA]; et al, 22-CV-00011 (RPK) (LB) (U.S. District Ct. N.Y. 2022) He filed a Federal Lawsuit in the United States District Court of New York arising out of same allegations. District Court Judge Rachael P. Kovner dismissed the case stating that the lawsuit was repetitive, frivolous, and a vexatious lawsuit. The dismissal was issued May 10, 2022.

I had a very active trial practice for nearly twenty years prior to taking the Bench. I handled civil, domestic and criminal matters. During my practice I have argued before the South Carolina Supreme Court, the South Carolina Court of Appeals and the Fourth Circuit Court of Appeals. During my practice, I handled four death penalty cases that were tried to their conclusion, including the death penalty phase. None of my clients were executed. I handled several capitol cases that were resolved short of trial.
