formal provisions of the Code of Judicial Conduct and the informal guidelines of proper judicial discretion apply to me in all of my activities at all times. I restrict my posting to information about or photographs of my family and justice-related issues. As an example of the latter category, I will sometimes re-post or "like" items from the South Carolina Access to Justice Commission, which I chair, in an effort encourage lawyers and others to promote access to justice. In recent years, my use of social media has been primarily to access news and other current events, with the occasional posting of family information and pictures.

Yes. I served as a Circuit Court Judge from July 1, 2000 to February 3, 2010. From that date until February 9, 2016, I served as the Chief Judge of the South Carolina Court of Appeals. From February 9, 2016 until today, I served as an Associate Justice on the Supreme Court of South Carolina.

I was elected to each position by the General Assembly.

29. Have you taught law-related courses or lectured at bar association conferences, educational institutions, or continuing legal or judicial education programs? If so, briefly describe each course or lecture.

Yes. In the past, I kept a detailed list of all the legal presentations I made. When I filed my application for the Supreme Court in 2015 and 2016, I included 131 specific presentations between the year 2000 and the date of my last application, which was in the spring of 2016. In part because members of the General Assembly criticized me (some jokingly; some not) for taking up so much space (10 full pages) in my application with this list, I stopped keeping a list of all legal presentations. So, following the instructions in the "Candidate Instructions" memo, here is a brief description of the dozens of courses I have taught or lectures I have given since the spring of 2016:

- (a) I teach a 2-hour, semester-long class each fall at the USC Rice School of Law entitled Advanced Evidence.
- (b) In approximately 2006, working with the S.C. Bar, I designed an annual, all-day continuing legal education seminar (CLE) on the law and practice of evidence called "It's All A Game." I organized and presented at this CLE every year until

approximately 2020 when I turned the responsibility for organizing it over to now-Circuit Judge Daniel Coble.

- (c) I have given a number of CLE presentations at local chapters of the American Board of Trial Advocates (ABOTA) and the southeastern chapter of ABOTA on one occasion in Destin, Florida. I gave the ABOTA James Otis Lecture in the House Chamber on September 13, 2019.
- (d) I have given CLE presentations at most of the South Carolina Bar annual conventions and several South Carolina Judicial Conferences since my election to the Supreme Court in 2016.
- (e) I have given several CLE presentations to local bar associations around the State, including the Rock Hill Bar, and the Hilton Head Island Bar, the Greenwood Bar, and at least twice at the Greenville Bar's Annual CLE.
- (f) I have spoken on numerous occasions to the South Carolina Magistrate Judges Association in both Myrtle Beach and Columbia.
- (g) In the first several years after 2016, I gave numerous CLE presentations through the South Carolina Bar, such as at the annual Criminal Law Update and what used to be an annual program related to the new 5th edition of South Carolina Law of Torts. I cut back significantly in the past five years on making CLE presentations through the South Carolina Bar.
- (h) I have given several CLE presentations to South Carolina attorney groups such as the Solicitors' Conference, the Public Defenders Association, the Association of Criminal Defense Lawyers, the Defense Trial Attorneys Association (Civil), the Injured Workers Advocates, and the Association for Justice.
- (i) I have been invited to give several CLE presentations to out-of-state legal groups, such as:

Yes. My name is sometimes listed as a defendant in federal lawsuits I never find out about because I am not served. The following are the lawsuits of which I am aware.

Douglas M. Thompson, an inmate in the South Carolina Department of Corrections, sued the Court of Appeals and others in U.S. District Court. I have seen the complaint, but I have not been served with it. I do not know the status of this case.

I was sued in U.S. District Court by Michael A. McKeown, who I believe is an inmate who plead guilty before me. The case was dismissed on summary judgment.

I was sued by Donald Strable in U.S. District Court for \$21 million. The allegations arose out of my having been assigned as administrative Circuit Judge for all the lawsuits he filed against other judges. Because the case was filed *pro se*, he was not allowed to serve me without the permission of the Federal Court, and that permission was denied. The case is over.

I was listed as a defendant in Rochester v. L. Casey Manning, 2004-MC-00008. However, I was never served with a summons and complaint and never participated in the case. I have no idea what the allegations against me were. As far as I know, the case has been dismissed.

A former client of mine, Newco Electrical Supplies, Inc., and one of its owners James H. Vaughn Jr., sued me and my co-counsel in the case. The case was filed in Greenville County, case number 03-CP-23-3354. The case was dismissed on my motion for summary judgment.

I was served with a Petition for a Writ of Prohibition in the Supreme Court of South Carolina in regards to my role as the assigned judge in State v. Jerry Buck Inman, a death penalty case in Pickens County. The Court assigned the case to another judge in a written Order.

In 2007, I was sent a copy of what appeared to be a pleading filed by Glen Laconey, a defendant in a case before the South Carolina Supreme Court alleging the unauthorized practice of law, in which I had been assigned to be the Special Referee. I do not believe this was a lawsuit, I have no reason to believe it was ever filed, and I was never served with a summons.

I was named as a defendant in Fishbourne v. Murdaugh, et al., 3:24-cv-4472-JFA. I was never served. The suit was dismissed on February 11, 2025.

No. However, the following events occurred regarding my 2019 federal tax return.

As I do every year, I retained an accountant to prepare my federal and state returns for 2019. The accountant completed the returns and I mailed the federal return to the IRS for filing. I paid the amount the accountant calculated I owed with the filing of the return: \$2012. I cannot remember if I included a check or paid the amount electronically. Four years later, on August 8, 2023, the IRS wrote me acknowledging receipt of \$26,368 in tax payments, but contending, "We have no record of receiving your tax return." As directed, I had my accountant provide the IRS with the return the accountant prepared years before. Nineteen months after that, on March 3, 2025, the IRS sent me a notice stating (1) I owed \$8298.20 for the 2019 tax year, (2) it had applied the \$1246 refund I was due for 2023 to that amount, and (3) "the amount you owe for December 31, 2019 is \$7052.20." The notice provided no explanation why the accountant's calculation to the contrary was mistaken, and provided no specific due date for the payment of those funds. I immediately turned the notice over to my accountant for him to determine whether he miscalculated the amount of taxes I owed or—as I suspect—the IRS miscalculated the taxes I owed. It is my understanding the accountant was promptly in touch with the IRS to determine the reason for the additional charge, but that the accountant heard

nothing from the IRS in return. On May 12, 2025, the IRS sent me another notice stating "we have not received your overdue tax after sending several notices to you. You must pay your balance immediately or we may levy (seize) your property." I immediately paid the \$7052.20 the IRS claimed was due. I have no record of the "several notices" referenced in the May 12 document. My accountant remains in contact with the IRS to determine the reason for the additional charge. I still do not know whether the discrepancy resulted from my accountant's error or the IRS's error, but it remains my expectation that the IRS will ultimately repay me the \$7052.20. All amounts the IRS contends were due, however, are paid.

42. Have you ever defaulted on a student loan? If so, please provide details.

No. In full disclosure, however, the USDOE reported to credit agencies that I was "delinquent" in April of 2025. While this information is not responsive to your question because it was not a "default," you will see it on my credit report, so I am going to go ahead and disclose it. First, I was not delinquent, but through its own error USDOE charged me for payments that were not due and did not notify me of the charges. Second, I learned of the erroneous charges in May of 2025, and immediately cleared the matter up. USDOE itself then correctly noted the accounts were current. I did not learn of this report to credit agencies until August 4, and though I have requested USDOE to correct the error it acknowledged to me that it made, it has refused to correct their mistake in making the initial report.

I am paid a salary for my work. My supervisor has been the Associate Dean for Academic Affairs, first Colin Miller and currently Susan Kuo.
