re-established operations of the firm in 2005, at which time I joined my father as an office assistant, runner, and law clerk.

(b) 2010 – 2025: West Law Firm, PA (formerly West Law Firm, LLC). Upon my admission to the South Carolina Bar in the year 2010, I joined West Law Firm as a legal associate, becoming a partner in the year 2012. In the early years of my career as a general practitioner in a small town law firm, I became involved in various matter types including estate planning, criminal defense, DUI prosecution, child protective services actions, civil asset forfeitures, property disputes and general litigation. In 2013 my practice shifted predominantly toward real estate, probate, and estate planning. I focused on real estate litigation, quiet title and partition actions, and Eminent Domain litigation.

(c) 2011 – 2015: Berkeley County Bar Association. I served as a board member and officer of the Berkeley County Bar Association, beginning in 2011, serving as Secretary-Treasurer from 2013 – 2015.

(d) 2016 – 2018: The Center of Heirs Property Preservation. I served as a member of the Board of Directors of The Center for Heirs Property Preservation.

(e) 2024 – 2025: West Law Firm, PA. In 2024 I undertook daily financial management for West Law Firm. This included maintaining various bank accounts, managing client funds, managing ongoing firm income and expenses, payroll management, and the day-to-day financial operations of West Law Firm.

(f) 2025 – Present: Master-in-Equity for Berkeley County. I was sworn in as Master-in-Equity on March 6, 2025. I have undertaken all duties of the Master's Office including status conferences, various hearings, trials, financial management and daily management of the department. With the great assistance of my Administrative Specialist, Cheryl Lawrence, I am learning the practical and administrative components of financial account management within the Master's Office. Prior to my appointment, I was responsible for financial management for West Law Firm. My duties included maintaining various bank accounts, managing client funds, managing ongoing firm income and expenses, payroll management, and the day-to-day financial operations of West Law Firm. My experience in private practice prepared me for my financial responsibilities as Master-in-Equity.

Confirmation by The South Carolina House of Representatives and The South Carolina Senate followed shortly thereafter. I was sworn in by The Honorable Dale E. Van Slambrook on March 6, 2025, and immediately assumed my judicial duties. Jurisdiction of the Master is defined in Rule 53, South Carolina Rules of Civil Procedure. Specifically Rule 53(b) pertaining to the mechanics of reference from the Circuit Court and Rule 53(c) pertaining to powers conferred to the Master. A Master has the same powers that a Circuit Judge has sitting in a non-jury matter in adjudicating the matters defined

in the Order of Reference. A Master has no power or authority except that which is given to him by the Order of Reference.
