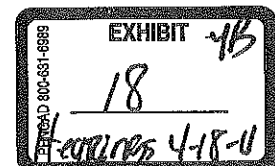

I would like to make two corrections to the sworn statement to be included in transcript of public hearings previously submitted.

As to question 14, my legal experience chronologically would be:

- 1978-1980, I was an assistant public defender in Richland County working in Family Court, Magistrate Court, and General Sessions Court.
- 1980-1982, I was an assistant solicitor in Richland County in Family Court and General Sessions.
- 1982-1984, I was an assistant public defender in Richland County working in Family Court, Magistrate Court, and General Sessions Court. 1984-1986, I was the public defender of Beaufort County.
- 1986-1987, I was an assistant solicitor in Greenville County practicing in General Sessions Court.
- 1987-1988, I was in private practice in Greenville primarily practicing in Family Court and Criminal Courts (Magistrate, General Sessions, and Federal Court).
- 1989-1992, I was the public defender of Richland County.
- 1992-1994, I was an associate with John Daus, Esquire practicing primarily in Family Court and Criminal Courts.
- 1994-1996, I was in private practice at the Quinn Law Office in Beaufort practicing primarily in Family Court and Criminal Courts.
- 1996-1999, I was an associate with the firm of Moss and Kuhn in Beaufort, South Carolina practicing primarily in Family Court and Criminal Courts, although I additionally practiced some in Common Pleas.
- 1999-2002, I was an assistant solicitor in Greenville County practicing in General Sessions Court.


