In emergency situations I do consider *ex parte* requests, but limit my considerations to the pleadings and do not engage in any conversation with counsel beyond that.

I would likely recuse myself if a party was uncomfortable with my presiding over their case.

7. How do you handle the appearance of impropriety because of the financial or social involvement of your spouse or a close relative?

This has not come up, but if there is an "appearance" of impropriety, I would recuse myself.

8. What standards have you set for yourself regarding the acceptance of gifts or social hospitality?

On a personal basis, I accept gifts or social hospitality only from long-standing relationships which precede my time on the Bench and which do not give any appearances of impropriety.

We keep updated records so we can track outstanding orders and matters under advisement.

Before hearing cases involving a guardian, I require the GAL to appear and report their activities to the Court. In most instances, the GAL files their written report so it is made a part of the Court record.

I do not believe my role is to set public policy.
