- 1. Why do you want to serve another term as a Family Court Judge?
 I enjoy serving the citizens of South Carolina and believe I am making a difference in the lives of some of the children that appear before me, especially the ones that appear over and over again in Juvenile Drug Court. I find the job rewarding and it makes me feel like the most blessed person in S.C. when I go home to my small problems.
- 2. Do you plan to serve your full term if re-elected? yes
- 3. Do you have any plans to return to private practice one day? no
- 4. Have you met the statutory requirements for this position regarding age, residence, and years of practice? yes
- 5. What is your philosophy regarding *ex parte* communications? Are there circumstances under which you could envision *ex parte* communications being tolerated?
 - if the question is procedural in nature an ex parte communication may be permissible. If the issue is substantive and is truly an emergency I may entertain the issue and get the parties into court as quickly as possible so that the other party is not prejudiced.
- 6. What is your philosophy on recusal, especially in situations in which lawyer-legislators, former associates, or law partners are to appear before you?
 - If I have a continuing close relationship with anyone, I will not hear a contested matter. If the attorney's have an agreement which they are asking the court to place on the record and everyone waives any possible conflict after full disclosure, I will place the agreement on the record.
 - I would not hear a contested case with any lawyer in which I had a close personal relationship.
- 7. If you disclosed something that had the appearance of bias, but you believed it would not actually prejudice your impartiality, what deference would you give a party that requested your recusal? Would you grant such a motion?
 - If there was someone else that could hear the case, I would exchange dockets with that judge. If I were the only judge, I would consider that the appearance of bias compared to the impact of a continuance on

- the parties and/or children and make the decision on a case by case basis. I would also take into consideration that the attorney may just be judge shopping.
- 8. How do you handle the appearance of impropriety because of the financial or social involvement of your spouse or a close relative?

 I would hear no case in which my spouse or a close relative had a financial interest. If there was a social involvement I would make the decision on the degree of social involvement.
- 9. What standards have you set for yourself regarding the acceptance of gifts or social hospitality?
 We have many friends that are lawyers and I believe it is important for the judiciary to socialize with the bar but this can be done without accepting anything of value. If I were invited to a party I would go. If I were invited to go on a trip with them, I probably would not go.
- 10. How do you handle a situation in which you became aware of misconduct of a lawyer or of a fellow judge? I would have no choice but to report them, if they had not already been reported.
- 11. Are you affiliated with any political parties, boards or commissions which, if you were re-elected, would need to be re-evaluated?
- Do you have any business activities that you have remained involved with since your election to the bench?No, however, I do own 25% of a business with my sister, but I do not work in the business. I occasionally attend a board meeting.
- 13. Since family court judges do not have law clerks, how do you handle the drafting of orders?

 When I decide a case, I type a set of instructions and send them to each attorney and/or litigant involved. I ask the prevailing attorney to draft the order for me. If the order is not to my satisfaction, I request that it be sent to me by email or disk so that I can insert the appropriate changes. I do not have time to draft most of the orders from the cases I hear. If I had to draft each order, my court time would be cut at least in half.
- 14. What methods do you use to ensure that you and your staff meet deadlines?My assistant and I both keep separate calendars.
- 15. What specific actions or steps do you take to ensure that the guidelines of the Guardian Ad Litem statutes are followed during the pendency of a case?
 - The best and easiest way to do this is to appoint good competent guardians. I have recessed cases after testimony has been taken when I did not feel that the guardian had done a complete investigation. I then bring resume the trial after the guardian has

- completed his investigation. I would not finish a trial if I did not feel the guardian had not done his job.
- 16. What is your philosophy on "judicial activism," and what effect should judges have in setting or promoting public policy?

 There are many good important groups that I would like to get involved with but feel it could cause problems. There are enough good things a judge can get involved with to help the system without getting involved in the controversial organizations.
- 17. Canon 4 allows a judge to engage in activities to improve the law, legal system, and administration of justice. What activities do you plan to undertake to further this improvement of the legal system?

 I have run a juvenile drug court for over 10 years. I plan to continue presiding over this program as long as the funding from Charleston County continues.

A minister, Alan Kilpatrick, and I started a father initiative program called 2nd Chance. It involved volunteers going into the jail for 30 days and presenting the Celebrate recovery program. The father's were then conditionally released from incarceration and ordered to appear before the court once a month for six months showing that they are paying their child support. They must attend a meeting each week and work with a mentor. All the workers are volunteers.

I have worked with the Charleston County school district in a truancy program for about 3 to 5 years. It also involves the same children appearing before the court once a month. The children must be attending school or be punished.

I will continue to work with all of these programs.

- 18. Do you feel that the pressure of serving as a judge strains personal relationships (i.e. spouse, children, friends, or relatives)? How do you address this?
 - It does strain relationships at times, but I deal with this through prayer and exercise.
- 19. Are you involved in any active investments from which you derive additional income that might impair your appearance of impartiality?
- 20. Would you hear a case where you or a member of your family held a de minimis financial interest in a party involved?
 No, I would not unless it was an uncontested agreement where the entire de minimis financial interest was disclosed on the record and all parties waived any conflict.
- 21. Do you belong to any organizations that discriminate based on race, religion, or gender? no
- 22. Have you met the mandatory minimum hours requirement for continuing legal education courses? yes
- 23. What do you feel is the appropriate demeanor for a judge?

- A judge should maintain order in the court room while remaining calm, patient and unemotional.
- 24. Do the rules that you expressed in your previous answer apply only while you are on the bench or in chambers, or do these rules apply seven days a week, twenty-four hours a day?
 A calm and patient demeanor should be maintained on and off the bench.
- 25. Do you feel that it is ever appropriate to be angry with a member of the public, especially with a criminal defendant? Is anger ever appropriate in dealing with attorneys or a pro se litigant?

 No, I don't see where that emotion could accomplish anything in the court room.

 The only monies I will spend on this campaign will be in mailing this application and going to Columbia.
