- 5. What is your philosophy regarding ex parte communications? Are there circumstances under which you could envision ex parte communications being tolerated?


Ex Parte communications are to be avoided. They may be tolerated in emergency situations or for scheduling and administrative purposes.

I deal with matters promptly. Specific deadlines are put on a calendar and handled in a timely manner by me and my Administrative Assistant.

Ensure the order appointing the Guardian Ad Litem sets forth clearly the duties and powers of the Guardian Ad Litem, and direct what the court wants from the Guardian Ad Litem. They are subject to cross examination during the proceedings.

Decisions are to be made on existing law as related to the facts, and not for some politically motivated interest.
