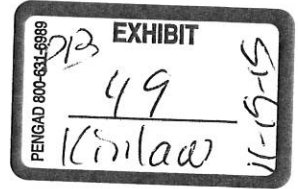


AMENDMENT TO PERSONAL DATA QUESTIONNAIRE STATEMENT


