WITNESS AFFIDAVIT FORM

To The Commission on Judicial Conduct :

My name is Matt Younginer and I am filing a formal complaint and requesting an investigation into the unethical conduct of Judge Monet Pincus. Judge Pincus has become a cancer to the family court system and her behind the scenes approach to the bench is a danger to the children of South Carolina. I have learned through some very educated and knowledgeable attorneys, paralegals and guardians that Judge Pincus knows how to "work the system" and prides herself on sealing records so that the litigants can't expose her destructive conduct. The good news with my situation is that there are several items that were not sealed in my case that will clearly show the commission the corrupt manner in which this judge functions. Judge Pincus has struck up a friendship with some snake oil style therapist in this town and she constantly gives them business and children of S.C. are sent off to behavioral modification camps across the nation and they are having catastrophic consequences to these children.
