Yes. The matter of John T. Ray 2014-DE-J-0005. Mr. Ray filed a grievance in January, 2014 against me regarding an action where I did not recuse myself. In a previous action brought by his sister in 2010, I had recused myself. I had requested the clerk's office not schedule that matter in front of me because the sister's attorney had indicated she was instructed to file a grievance against me. No notice of a grievance was ever sent to me by the Disciplinary Counsel but I had decided not to hear any further matters concerning the sister's case in case a grievance was subsequently filed. Mr. Ray's 2014 grievance was dismissed as there was no ethical violation. I was also advised by the Disciplinary Counsel's office I did not have to recuse myself even if a grievance had actually been filed.
