QUICK REFERENCE GUIDE TO ROLL CALL VOTE HISTORY SEARCH & REPORT FEATURES

Introduction/Overview

The roll call votes cast by Senators and Representatives are a matter of public record and are recorded in the official Journals of the Senate and House of Representatives (House). Prior to Session 119 (2011-2012), roll call votes could only be accessed from the Journals.

Beginning with the 2011 Session, the South Carolina Legislature began publishing roll call votes on the Senate and House Vote History pages on the legislative website, www.scstatehouse.gov. The roll call votes are published after adjournment of each daily Senate and House session. The Vote History pages provide a list of all roll call votes recorded and link to the Bills, Amendments, and each individual roll call designated by a Vote Number. The vote history results allow the data to be sorted and provide a link to a printer friendly version of each roll call vote.

Effective March 28, 2013 Senate and House roll call votes can be searched using multiple criteria to perform searches by Chamber, on specific Legislation, and by each Legislator. Additionally, printer friendly reports are available for all search results. The reports may be printed, saved as a PDF file, or sent as an email attachment.

Senate and House roll call votes may be searched from several locations on the legislative website. The Quick Reference Guide provides direction to these locations and the types of searches available.
