### COURSE DESCRIPTION AND OUTLINE: CONTINUING EDUCATION SESSION ON HISTORY OF THE CATAWBA RIVER

This session is particularly geared towards helping the members of our Board of Historic Review (BHR) to better understand the history of the Catawba River, although Planning Commissioners, Board of Zoning Appeals members, and City staff also will be invited to attend.

Hope Matthews, the City's outdoor education coordinator, will present the session. Janice Miller, the City's historic preservation specialist and BHR liaison, will also be on hand but will not have a role in presenting the information.

The session will consist of a PowerPoint presentation (60 mins.) and a question and answer session (15 mins.) about the topic. The presentation will cover the early history of developing Lake Wylie, wildlife indigenous to the lake and river area, native peoples along the Catawba River, early industry along the river, and the importance of canals to the life of the river. Because the City of Rock Hill is seeing more and more development along the river, the various Board members need an understanding of—and a sensitivity to—its history.
