Traffic Impact Decisions and their Cross-Jurisdictional Importance

This will be a two-part program. The first part will be presented by Vic Edwards, SCDOT District 4 Traffic Engineer. The primary objective of a Traffic Impact Analysis is to enable Planning Commissions and City Councils to make properly informed recommendations and decisions on whether the impact of development on the transportation system can be approved, approved with conditions, or has severe consequences that warrant a denial. Mr. Edwards will present what should be considered in a technical analysis, such as road network efficiency, intersection and access improvements, and safety as well as the impacts on road users, pedestrians, and cyclists.

The second part of the program will be presented by David Hooper, Administrator of the Rock Hill-Fort Mill Transportation Study Area. Mr. Hooper will provide an overview of the latest growth, operating conditions, and planning priorities – and present the need for cross-jurisdictional coordination on Traffic Impact Analysis within the MPO area. Like squeezing a water bed, the impact of development in one area of the transportation system, especially on arterial roads and corridors, has consequences in jurisdictions further along the system. Discussion will be encouraged on how to best implement technical improvements and coordinate communication between jurisdictions.

#### Victor Edwards (SCDOT)

Victor Edwards is the District Traffic Engineer for SCDOT in District 4 which includes York County. During his 22 years at the SCDOT Vic has overseen many projects from differing perspectives - from before they start, to finish as well as maintaining them after completion. Before moving to York County in 1998, Vic worked with JA Jones Construction, and the Federal Aviation Administration.

Vic has attended The Citadel, University of South Carolina and Clemson University. He obtained both his Bachelors' and Masters' Degrees from Clemson University.

#### David F. Hooper (RFATS)

David is the MPO Administrator for the Rock Hill-Fort Mill Area Transportation Study – which is an intergovernmental transportation planning organization responsible for coordinating the development of transportation plans and programs for the eastern urbanized portion of York County and the northern portion of Lancaster County, South Carolina. The RFATS Study Area covers approximately 350 square miles, serves a planning area population of roughly 255,000, and is one of the fastest growing regions within the State of South Carolina.

As a federally mandated planning process, David is responsible for coordinating work in a range of areas that includes project planning and budgeting, social and environmental screening, congestion management, freight movement, public transit and air quality compliance, among many others. This process also requires active coordination with a number of federal and state agencies that includes the South Carolina Department of Transportation, the Federal Highway Administration, the Federal Transit Administration, the South Carolina Department of Health & Environmental Control, EPA as well as a host of other supporting organizations and interested parties within the greater Charlotte region.

David holds a bachelor's degree in political science and communication as well as a master's degree in public administration. David has experience in departments of finance, public works and planning.
