#### Advancing a Regional Trail and Greenway Network

This will be a two-part program. The first part will be presented by Bret Baronak, Project Director for The Carolina Thread Trail. The Carolina Thread Trail is a regional network of trails that connect 2.9 million people in 15 counties in North and South Carolina. The Thread Trail is an example of unprecedented regional collaboration that works to connect people and communities to nature and each other through its 1,610 miles of trails, greenways and blueways. Bret will discuss the genesis of The Carolina Thread Trail organization, relationships with other land conservancies, government partnerships, funding and implementation of a regional vision.

The second part of the program will be presented by John Gordon with the Anne Springs Close Greenway. The Anne Springs Close Greenway is a 2,100-acre nature preserve dedicated to serve the public as a natural buffer from urban development and a place for countless activities – from hiking, mountain biking and horseback riding, to picnics, kayaking and more. John will present the history and importance of this regional green space from formation to a future vision. Discussion will be encouraged on how to best implement green preservation and coordination between jurisdictions.


