#### Brief description of the Training or Program and its relevant content:

The SRS Community Reuse Organization, Inc. (SRSCRO) is a regional 501(c)(3) non-profit serving a five-county region of South Carolina. The SRSCRO was established to provide leadership in promoting the common economic interests and benefits of residents, businesses, and industries. Its goal is to support stable and balanced economic growth throughout the area by acting as an economic development support organization and a unified voice regarding missions and activities impacting the U.S. Department of Energy's Savannah River Site.

Over the past year, the SRSCRO has conducted an assessment of current and future housing demands, supply, and workforce needs in the five-county region. The proposed training program will share the study results with Aiken County planners and discuss how the data influences the county's long-range plans. The session aims to improve participants' understanding of the national and regional economics of housing. It will address barriers to providing housing for the entire workforce and explore policies that can facilitate housing development.

Joel Duke has over thirty years of experience in county, municipal, and regional planning. Since June 2019, he has served as the Chief Development Officer (Planning Director) for Aiken County. In that role, he is responsible for administering the county's comprehensive plan, land management

regulations, building and related codes, regional transportation planning, code enforcement, and floodplain management.

Prior to his tenure with Aiken County, he served twenty-two years as the planning director for a municipal government in Alabama, where his responsibilities also included managing historic preservation regulations, downtown redevelopment authority, geographic information system, annexation policy, and ADA regulations. During his time as the city's planner, he guided major revisions to the city's comprehensive plan, developed and executed a downtown revitalization strategy, coordinated the redevelopment of a historic factory complex, and contributed to the development of a regional growth strategy.

Joel holds a Master of Public Administration from the University of Alabama at Birmingham and an undergraduate degree from Jacksonville State University. He is a member of the American Institute of Certified Planners (AICP) and the American Planning Association.

Robbie Bennett has been promoting economic development for over 19 years and has been in the Greater Augusta area for more than 14 years. In 2013, he became Columbia County's economic developer and served as the Executive Director of the Development Authority of Columbia County. Throughout his career in economic development, he has supported the creation or retention of more than 10,625 jobs and facilitated \$1.25 billion in capital investment from companies such as Amazon, Club Car, John Deere, GIW, Starbucks, Rural Sourcing, and others. Recently, he has led efforts for the new White Oak Business Park at I-20 and helped establish redevelopment powers for Columbia County and the City of Harlem. His contributions and impact in economic development are made possible by the support of his wife and daughters.

In 2012, he was recognized by Augusta Magazine and the Augusta Metro Chamber as one of "Augusta's Top 10 in 10 Young Professionals to Watch."
