I. CALL TO ORDER

- II. S. 569 -- Senator Shealy --** A BILL TO AMEND SECTION 63-13-20(4) OF THE 1976 CODE, RELATING TO THE DEFINITION OF CHILDCARE FACILITIES, TO CLARIFY THE TYPES OF DAYTIME PROGRAMS AND DAY CAMPS TO WHICH THE DEFINITION APPLIES; TO AMEND SECTION 63-13-210, TO PROVIDE THAT THE OWNER OR OPERATOR OF A CHILDCARE CENTER, GROUP CHILDCARE HOME, OR FAMILY CHILDCARE HOME MUST CARRY LIABILITY INSURANCE; TO AMEND ARTICLE 1, CHAPTER 13, TITLE 63, BY ADDING SECTION 63-13-220, TO PROHIBIT THE USE OF ABC VOUCHERS BY CERTAIN CHILDCARE FACILITIES AND TO REQUIRE THE GENERAL ASSEMBLY TO APPROPRIATE FUNDS ANNUALLY; TO AMEND ARTICLE 1, CHAPTER 13, TITLE 63, BY ADDING SECTION 63-13-230, TO PROVIDE EMPLOYEE AND FACILITY REQUIREMENTS AND CONDITIONS; AND TO AMEND ARTICLE 3, CHAPTER 13, TITLE 63, BY ADDING SECTION 63-13-470, TO PROVIDE FOR LICENSING AND APPROVAL REQUIREMENTS FOR PRIVATE CHILDCARE CENTERS AND GROUP CHILDCARE HOMES.

H. 3116 -- Representatives Crawford, Norrell, Felder, Pitts, Yow, King, Henegan, Erickson and Knight -- A BILL TO AMEND SECTION 63-7-40, AS AMENDED, CODE OF LAWS OF SOUTH CAROLINA, 1976, RELATING TO THE PLACEMENT OF INFANTS AT DESIGNATED LOCATIONS WITHOUT CRIMINAL LIABILITY, SO AS TO ALLOW THE PLACEMENT OF AN INFANT

NOT MORE THAN ONE YEAR OLD AT A SAFE HAVEN AND TO CHANGE THE DEFINITION OF "INFANT".
