There will be a meeting of the Regulatory & Local Government Subcommittee of the Senate Labor, Commerce and Industry Committee on February 19, 2020 at 10:00 a.m. in room #307 of the Gressette Building. ~~The following~~ legislation and regulations will be on the agenda:

**A. S.330** S. 330 -- Senators Davis, Gregory and Climer: A BILL TO ENACT THE "OCCUPATIONAL LICENSURE REFORM ACT"; TO AMEND ARTICLE 1, CHAPTER 3, TITLE 41 OF THE 1976 CODE, RELATING TO THE DEPARTMENT AND DIRECTOR OF LABOR, LICENSING, AND REGULATION, BY ADDING SECTION 41-3-45, TO PROVIDE THAT **CERTAIN REGULATIONS MUST UNDERGO LEGISLATIVE REVIEW** TO IDENTIFY WHETHER PRESENT, SIGNIFICANT, OR SUBSTANTIATED HARMS WOULD EXIST IN THE ABSENCE OF THE REGULATION THAT WOULD WARRANT GOVERNMENT INTERVENTION AND, IF SO, TO PROVIDE THAT THE SENATE COMMITTEE ON LEGISLATIVE OVERSIGHT AND THE HOUSE OF REPRESENTATIVES COMMITTEE ON LEGISLATIVE OVERSIGHT SHALL CONSIDER ALTERNATIVE PROVISIONS THAT WOULD BE THE LEAST RESTRICTIVE AND IMPOSE THE LOWEST BURDENS AND COSTS WHILE PROTECTING CONSUMERS FROM HARM.
