**H. 3876** -- Reps. Murray, McDaniel, Gilliard, Robinson, R. Williams, King, Henegan, Brawley, Carter, Bustos, M.M. Smith, Dabney, Howard, K.O. Johnson, McKnight, Tedder and J.L. Johnson: A BILL TO AMEND THE CODE OF LAWS OF SOUTH CAROLINA, 1976, BY ADDING SECTION 7-1-110 SO AS TO REQUIRE DIRECTORS OF LICENSED NURSING HOMES OR COMMUNITY RESIDENTIAL CARE FACILITIES

**H. 3888** -- Reps.
