**Summary:** State Agency Rule Making

AN ACT TO AMEND THE SOUTH CAROLINA CODE OF LAWS BY AMENDING SECTIONS 1-23-115, 1-23-120, AND 1-23-125, ALL RELATING TO THE REQUIREMENTS AND PROCEDURES FOR REGULATIONS, ALL SO AS TO PROVIDE FOR THE TOLLING OF THE PERIOD OF LEGISLATIVE REVIEW FROM THE SECOND FRIDAY IN MAY THROUGH THE SECOND MONDAY THE FOLLOWING JANUARY, AND TO PROVIDE FOR A ONE-HUNDRED-TEN-DAY LEGISLATIVE REVIEW PERIOD. - RATIFIED TITLE
