### **S\*0336 (Rat #0098, Act #0095 of 2026) General Bill, By Alexander, Massey and Rankin**

#### **Summary:** Judicial Elections

AN ACT TO AMEND THE SOUTH CAROLINA CODE OF LAWS BY AMENDING SECTION 2-19-90, RELATING TO JUDICIAL ELECTIONS BY THE GENERAL ASSEMBLY IN JOINT SESSION, SO AS TO SET THE FIRST WEDNESDAY OF MARCH FOR THE ELECTIONS OF JUDGES BY THE GENERAL ASSEMBLY; AND BY AMENDING SECTION 2-19-80, RELATING TO THE JUDICIAL MERIT SELECTION COMMISSION AND NOMINATION OF CANDIDATES, SO AS TO REVISE THE TIME FRAME FOR THE RELEASE OF THE COMMISSION'S FORMAL REPORT AS TO QUALIFICATIONS OF ITS NOMINEES. - RATIFIED TITLE
