AN ACT TO AMEND THE SOUTH CAROLINA CODE OF LAWS BY ADDING SECTION 50-21-128 SO AS TO PROHIBIT SWIMMING WITHIN FIFTY FEET OF A PUBLIC BOAT LANDING OR RAMP MAINTAINED BY THE SOUTH CAROLINA PUBLIC SERVICE AUTHORITY IF APPROPRIATELY MARKED. - RATIFIED TITLE
