A Bill to reauthorize the State Board of Nursing for six years; and to amend Sections 40-33-530 and 40-33-730, Code of Laws of South Carolina, 1976, relating to the qualifications for an applicant to be a registered or practical nurse, so as to delete from the requirements that an applicant must be in good physical and mental health and is of good moral character.-amended title
