A Bill to enact the South Carolina Water Use Reporting and Coordination Act so as to authorize the South Carolina Water Resources Commission to promulgate regulations to require the reporting of substantial use, withdrawal, or diversion or obtaining of surface, underground and other waters of the state and drilling for water and prescribe guidelines for such regulations.-at
