

## Session 117 - (2007-2008)

### **S\*0261 (Rat #0001, Act #0152 of 2007) General Bill, By Martin and Alexander**

**Summary:** Pickens County School Board of Trustees

AN ACT TO REQUIRE THAT ANY MEASURE BY THE PICKENS COUNTY SCHOOL BOARD OF TRUSTEES FOR THE ANNUAL OPERATING BUDGET, A SUPPLEMENTAL BUDGET OR APPROPRIATION THAT EXCEEDS ONE-HALF OF ONE PERCENT OF THE OPERATING BUDGET, OR A MEASURE THAT RESULTS IN THE DISTRICT INCURRING DEBT, MUST RECEIVE READINGS ON THREE SEPARATE DAYS, TO PROVIDE THAT FIRST READING MAY BE BY TITLE OR DESCRIPTION ONLY, THAT SECOND AND THIRD READING MUST BE APPROVED BY A MAJORITY OF THE BOARD MEMBERS, AND THAT THIRD READING MUST NOT BE CONDUCTED PRIOR TO ONE WEEK FOLLOWING THE DATE OF SECOND READING. - ratified title
