AN ACT TO AMEND SECTION 40-47-211, AS AMENDED, CODE OF LAWS OF SOUTH CAROLINA, 1976, RELATING TO THE MEDICAL DISCIPLINARY COMMISSION OF THE STATE BOARD OF MEDICAL EXAMINERS, SO AS TO FURTHER PROVIDE FOR THE QUALIFICATIONS OF LAY MEMBERS OF THE COMMISSION AND FOR LAY COMMISSIONER TERMS AND PROCEDURES FOR FILLING VACANCIES; AND TO AMEND SECTION 40-47-213, RELATING TO DISCLOSURE OF INFORMATION IN REGARD TO BOARD OF MEDICAL EXAMINER PROCEEDINGS, SO AS TO FURTHER PROVIDE FOR SUCH DISCLOSURE AND FOR THE PROCEEDINGS OF THE BOARD IN REGARD TO COMPLAINTS. - ratified title
