### **S\*0320 (Rat #0441, Act #0003 of 2001) General Bill, By Peeler**

**Summary:** Bass, large-mouth; taking of in certain lakes, York County, Game Zone 4, when certain size unlawful; Fish and Game

A BILL TO AMEND CHAPTER 13, TITLE 50, CODE OF LAWS OF SOUTH CAROLINA, 1976, RELATING TO PROTECTION OF FISH, BY ADDING SECTION 50-13-385, SO AS TO PROVIDE THAT IT SHALL BE UNLAWFUL TO TAKE OR POSSESS LARGE-MOUTH BASS LESS THAN TWELVE INCHES IN LENGTH IN LAKE MARION, LAKE MOULTRIE, AND IN LAKE WYLIE LOCATED IN YORK COUNTY IN GAME ZONE 4, AND TO PROVIDE PENALTIES FOR A VIOLATION OF THE SECTION.-AMENDED TITLE
