A Bill to amend the Code of Laws of South Carolina, 1976, by adding Section 50-11-704 so as to make it unlawful to use artificial lights from any vehicle or water conveyance for the purpose of observing or harassing wildlife in Game Zone No. 4 and to provide a penalty for violations.
