### **H\*3910 (Rat #0069, Act #0054 of 2025) General Bill, By Davis, G.M. Smith and B.J. Cox**

AN ACT TO AMEND THE SOUTH CAROLINA CODE OF LAWS BY AMENDING SECTIONS 3-1-150 AND 63-3-510, RELATING TO JURISDICTION OVER CERTAIN LANDS RELINQUISHED BY THE UNITED STATES AND THE EXCLUSIVE ORIGINAL JURISDICTION OF THE FAMILY COURT, RESPECTIVELY, SO AS TO PROVIDE FOR CONCURRENT JURISDICTION WITH THE UNITED STATES IN CERTAIN MATTERS INVOLVING JUVENILES WITHIN A MILITARY INSTALLATION AND EXCLUSIVE ORIGINAL JURISDICTION THEREAFTER FOR CERTAIN MATTERS. - RATIFIED TITLE
