A Bill to amend Chapter 23 of Title 16 and Chapter 31 of Title 23, Code of Laws of South Carolina, 1976, relating to firearms, so as to provide that military firearms manufactured by a firm licensed by the federal government may be legally manufactured, transported, possessed and sold within the State by the manufacturer thereof, and to repeal Act 791 of 1988, relating to military firearms manufactured in Richland County.-amended title
