### **S\*0711 (Rat #0718, Act #0619 of 1988) General Bill, By Senate Judiciary**

A Bill to amend Section 8-21-310, Code of Laws of South Carolina, 1976, relating to fees paid to clerks of court and registers of mesne conveyances, so as to increase the fee for filing first complaint or petition, including application for a remedial and prerogative writ and bond for attachment in civil actions or proceedings from twenty-five to thirty-five dollars.-amended title
