S*0946 (Rat #0605, Act #0507 of 1990) General Bill, By Passailaigue

A Bill to amend Section 29-15-90, as amended, Code of Laws of South Carolina, 1976, relating to the lien of a laundry, dyer, dry cleaner, or other establishment engaged in the cleaning, dyeing, or alteration of personal property, so as to revise the requirements for disposal of personal property left at an establishment.
