AN ACT TO AMEND SECTION 56-1-100, CODE OF LAWS OF SOUTH CAROLINA, 1976, RELATING TO THE PERSONS WHO MUST SIGN AN APPLICATION OF A MINOR FOR A BEGINNER'S PERMIT, INSTRUCTION PERMIT, OR DRIVER'S LICENSE, SO AS TO DELETE THE TERM "INSTRUCTION PERMIT", AND TO REVISE THE LIST OF PERSONS WHO MUST SIGN THE APPLICATION OF AN UNEMANCIPATED MINOR. - ratified title
