**S\*1033 (Rat #0228, Act #0220 of 2014) General Bill, By Campbell, Leatherman, Setzler, O'Dell and Alexander**

**Summary:** Out-of-state businesses

AN ACT TO AMEND THE CODE OF LAWS OF SOUTH CAROLINA, 1976, BY ADDING SECTION 12-2-110 SO AS TO PROVIDE THAT AN OUT-OF-STATE BUSINESS OR EMPLOYEE THAT PERFORMS DISASTER OR EMERGENCY-RELATED WORK IN THIS STATE IS EXEMPT FROM CERTAIN LICENSING AND TAXING PROVISIONS DURING THE DISASTER PERIOD, TO DEFINE TERMS, AND TO PROVIDE NOTICE REQUIREMENTS. - ratified title
