**S\*1064 (Rat #0563, Act #0501 of 1988) General Bill, By Drummond, Leventis, Patterson and M.B. Williams  
Similar (H 3647)**

A Bill to reauthorize the existence of the South Carolina State Board of Examiners in Optometry for six years; to amend Sections 40-37-180 and 40-37-220, Code of Laws of South Carolina, 1976, relating to unlawful representation or advertising practices by optometrists, so as to broaden and more specifically define the practices which deal with limits on competition and unlawful representation and advertising; and to repeal Section 40-37-190 relating to the unlawful discounting of the cost of eye examinations or offering them as premiums.-amended title
