### **S\*1162 (Rat #0510, Act #0428 of 1998) General Bill, By Bryan**

A BILL TO AMEND SECTION 20-7-6845 OF THE CODE OF LAWS OF SOUTH CAROLINA, 1976, RELATING TO INSTITUTIONAL SERVICES FOR JUVENILES, SO AS TO REVISE THE STANDARDS FOR DETENTION FACILITY SIZE, CAPACITY, PERSONNEL, JURISDICTION, SERVICES AND HOLDING PERIODS APPLICABLE TO JUVENILE DETENTION FACILITIES THAT BENEFIT COUNTIES, MUNICIPALITIES, AND REGIONAL SUBDIVISIONS, AND TO PROVIDE CERTAIN TECHNICAL CHANGES.-AMENDED TITLE
