### **S\*1331 (Rat #0499, Act #0428 of 1990) General Bill, By Senate Banking and Insurance**

A Bill to amend the Code of Laws of South Carolina, 1976, by adding Section 2-7-73 so as to provide that every bill or resolution which mandates a health insurance coverage or the offering of a health insurance coverage must have attached to it a certain fiscal impact statement, and to provide for the manner in which this fiscal impact statement must be prepared.-amended title
