A Bill to authorize organized rescue squads and volunteer fire departments in this State to solicit funds from motorists within a municipality on the Friday prior to Easter and the Friday prior to Labor Day for the rescue squad and the Friday prior to National Memorial Day and the Friday prior to July fourth for the volunteer fire department.-amended title
