### **H\*2196 (Rat #0110, Act #0074 of 1987) General Bill, By J.D. Bradley, D.N. Holt and D.E. Martin**

A Bill to amend Section 6-11-650, Code of Laws of South Carolina, 1976, relating to the exemption of historical or recreational districts from the provisions of Article 3 of Chapter 11 of Title 6 concerning the alteration of boundaries and the issuance of general obligation bonds of special purpose districts, so as to delete recreational districts from the exemption.
