A Bill to alter the county lines of Charleston and Colleton Counties by annexing a certain portion of Charleston County to Colleton County, to make provisions for legal records, and to provide that Colleton County shall assume thirty-nine thousand nine hundred fifty-five dollars of the indebtedness of Charleston County transferred pursuant to this Act.
