**H\*2644 (Rat #0275, Act #0183 of 1981) General Bill, By D.O. Hawkins, C.D. Chamblee, J.G. Felder, J.V. Gregory, W.R. Lee, J.W. McLeod, D.L. Ogburn, Phillips, R.L. Rigdon, D. Sheppard and D.E. Winstead**

A Bill to amend Section 56-5-2720, as amended, Code of Laws of South Carolina, 1976, relating to the requirement for certain vehicles to stop at all railroad grade crossings, so as to require any vehicle permitted by the Department of Health and Environmental Control to carry hazardous waste to stop at such crossings.
