**H\*2752 (Rat #0811, Act #0681 of 1988) General Bill, By House Judiciary**

**Similar (H 2465)**

A Bill to amend Section 22-3-10, Code of Laws of South Carolina, 1976, relating to magistrates' civil jurisdiction, so as to increase the jurisdictional amount in magistrates' court cases from one thousand dollars to two thousand five hundred dollars, to provide that civil jurisdiction in magistrates' court is concurrent jurisdiction and to delete the civil jurisdiction of magistrates in cases of bastardy.-amended title
