A BILL TO AMEND SECTION 24-3-430, CODE OF LAWS OF SOUTH CAROLINA, 1976, RELATING TO INMATE LABOR IN PRIVATE INDUSTRY, SO AS TO AUTHORIZE THE USE OF INMATE LABOR BY A NONPROFIT ORGANIZATION, TO PROVIDE THAT A VIOLENT OFFENDER NOT PERFORM LABOR FOR A NONPROFIT ORGANIZATION OUTSIDE THE CONFIENS OF A CORRECTIONAL INSTITUTION, AND TO PROVIDE, FURTHER, THAT AN INMATE PARTICIPATING IN LABOR FOR A NONPROFIT ORGANIZATION NOT BENEFIT IN ANY MANNER CONTRADICTORY TO EXISTING STATUTES.-AMENDED TITLE
