### H\*3017 (Rat #0238, Act #0157 of 1989) General Bill, By Sharpe

A Bill to amend the Code of Laws of South Carolina, 1976, by adding Chapter 71 to Title 2 so as to provide for additional legislative members on boards and commissions under the jurisdiction of the Agriculture and Natural Resources Committees of the House of Representatives and the Senate and the Fish, Game and Forestry Committee of the Senate; and to amend Section 2-11-10, relating to the membership of the Legislative Council, so as to authorize the Chairman of the Judiciary of the Senate to appoint a designee.-amended title
