A Bill to amend Chapter 11, Title 9, Code of Laws of South Carolina, 1976, relating to the South Carolina Police Officers Retirement System, by adding Section 9-11-55 so as to provide that members of this System are entitled to credit for prior service for which credit may be established by members of the South Carolina Retirement System and to provide the formula for payment for the credit.-amended title
