### **H\*3120 (Rat #0127, Act #0071 of 1991) General Bill, By B.H. Harwell**

A Bill to amend the Code of Laws of South Carolina, 1976, by adding Section 50-11-706 so as to prohibit the use of artificial lights from a vehicle or water conveyance to observe or harass wildlife in Game Zones 9 and 10, provide exceptions and penalties, and authorize the lawful hunting of raccoon and fox.-amended title
